Dear Mr. Heath:

Thank you for your letter dated January 5, 2024 to EPA's letter dated December 21, 2023 regarding the 'Area 4 TCRA Removal Work Plan, Part 1.' The letter requested clarification on the requested 'next steps' for NCR Voyix to provide a revised work plan and design drawings, which were requested by January 31, 2024. The purpose of this letter is to provide the requested clarifications so that a revised submittal can be developed, and to formally extend the deadline until March 15, 2024 to accommodate input from the general contractor selected to perform the Part 1 work.

As requested, attached is a list of items that EPA identified as errors, omissions, or inconsistencies along with recommended corrections (see Attachment 1). Regarding the State of Michigan's comments to EPA on December 20, 2023 (see Attachment 2), please consider each comment, make the requested change(s) and/or propose an appropriate resolution to EPA for consideration in the column provided on the spreadsheet (see Attachment 3). Please address these issues, along with any changes as a result of general contractor input, into a revised submittal.

Regarding the estimated 20,000 yd³ of material proposed to be removed from the area along the RDB upstream of the dam, EPA has determined that additional characterization is needed in this area to determine appropriate stockpiling and management options. Sampling work will be conducted by EPA's START contractor as soon as possible.

Please submit a revised Removal Work Plan and corresponding design drawings **by March 15, 2024.**
